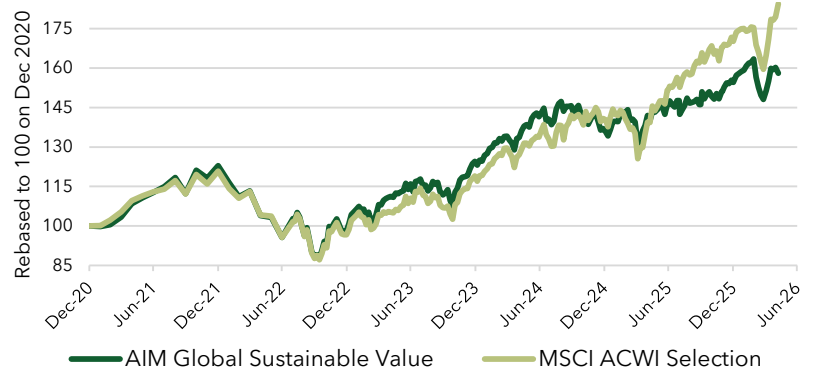

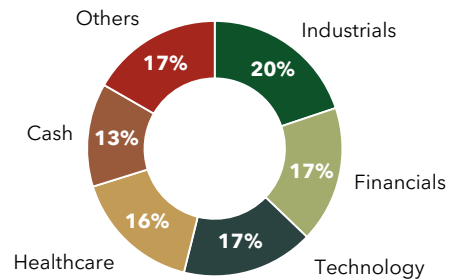

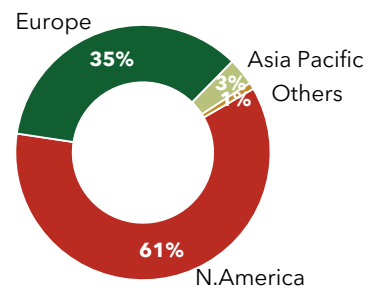

COMMENTARY

The fund lost **1.3%** while the benchmark gained **2.6%** over the week.

U.S. equity markets advanced, supported by strong corporate earnings and continued optimism around Artificial Intelligence (AI) linked stocks. However, gains were uneven across sectors, with energy and utilities under pressure. European equities were volatile, with investor sentiment weakening later in the week as renewed U.S.-EU tariff concerns weighed on markets.

Within the fund, technology was the top performer, while healthcare and industrials lagged. Performance was mainly affected by stock-specific weakness following quarterly results.
