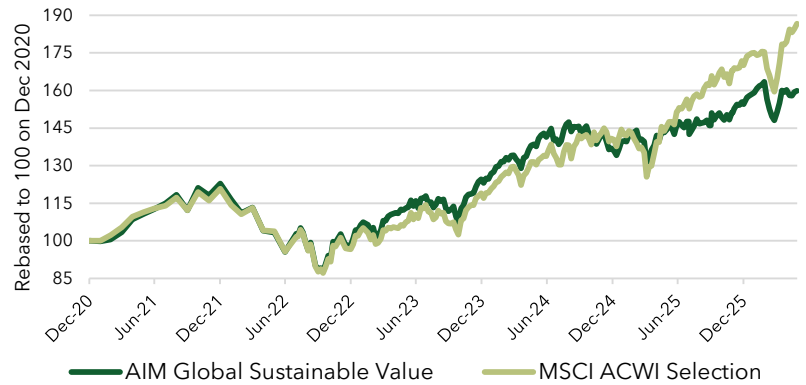

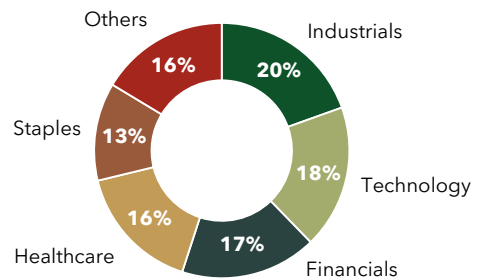

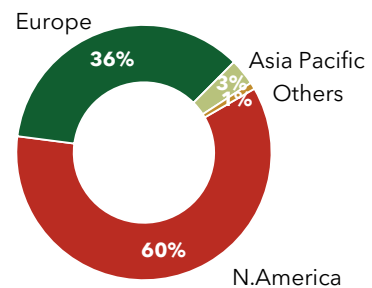

COMMENTARY

The fund and the benchmark gained **0.3%** and **1.1%** respectively, over the week.

U.S. equities advanced, supported by optimism around a potential U.S.-Iran agreement, lower oil prices, and continued momentum in Artificial Intelligence (AI) stocks. Investor sentiment remained positive amid signs of a ceasefire extension and easing geopolitical tensions.

European equities edged higher as investors monitored diplomatic developments and prospects for the resumption of energy flows through key trade routes.

Within the fund, technology and discretionary were the top performers, while staples and financials were the main detractors.
