



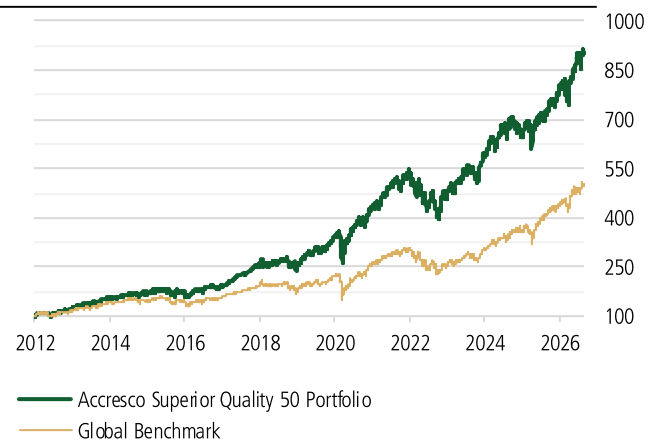
Accresco Superior Quality 50 Portfolio

Description

The **Accresco Superior Quality 50 Portfolio [ASQ50]** is composed of the 50 largest companies by market capitalization globally that meet high quality scores based on certain financial and managerial factors, including but not limited to the following three fundamental parameters: return on equity, earnings volatility and financial leverage. The portfolio is equally-weighted. The selection of the most promising companies is based on predefined, rules-based criteria. Rebalancing takes place semi-annually. A quarterly risk-control review (end of March, June, September, December) checks compliance with the dividend rules.

Chart since inception



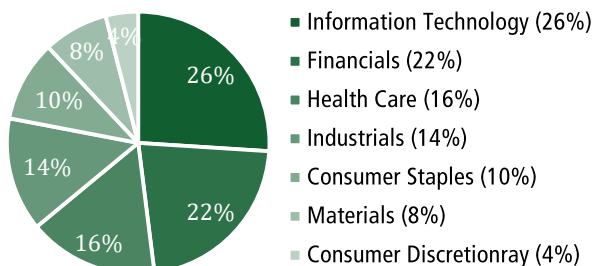

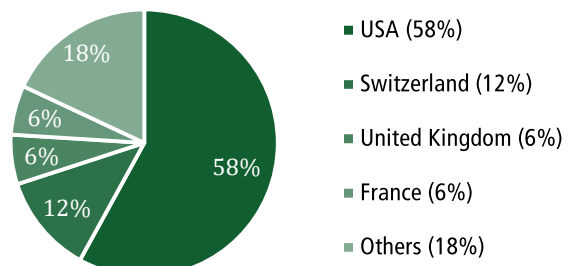
