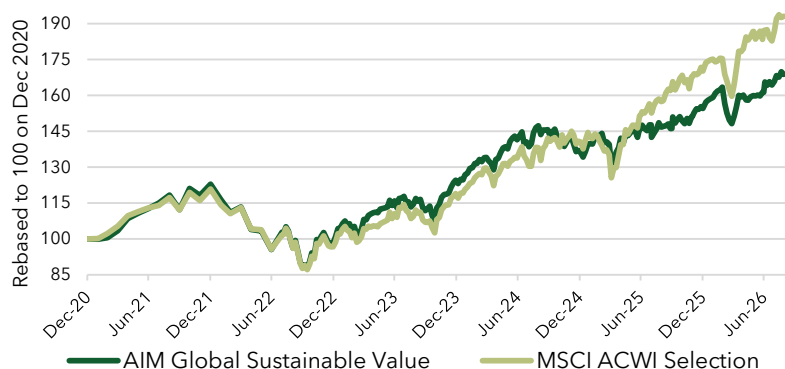

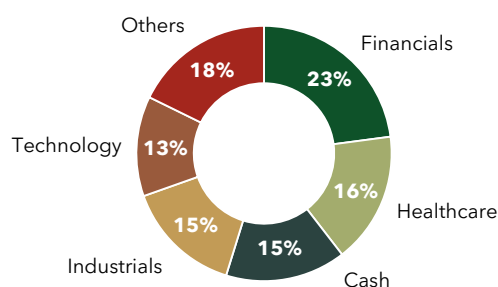

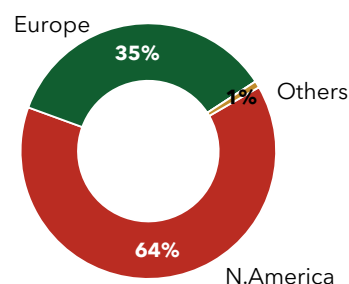

COMMENTARY

The fund declined by **0.6%** over the week, underperforming the benchmark, which gained **0.3%**.

U.S. equities were mixed, with large-cap technology stocks supported by strong Artificial Intelligence (AI)-related earnings, while mid- and smaller-cap stocks weakened. Sentiment was helped by lower oil prices, although investors remained focused on the Federal Reserve's policy outlook. European equities were broadly unchanged, as mixed economic data and Middle East developments weighed on sentiment, while technology stocks benefited from continued AI-related momentum.

Within the fund, positive contributions from technology and industrials were offset by weakness in financials and healthcare, which were the main detractors.
